Questions to ask Photographer & Videographer



How long have you been photographing weddings?

Can I see a portfolio or gallery of your previous wedding work?

Have you worked at my venue before? Can you provide examples of weddings at this location?

How would you describe your photography style (e.g., traditional, photojournalistic, artistic)?

How do you approach capturing special moments and details throughout the day?

Do you offer pre-wedding or engagement photo sessions? Can we discuss the style and location for these?

What packages do you offer? What's included in each package (e.g., number of hours, number of photos, prints, albums)?

What is your pricing structure? Are there additional fees for extra hours, travel, or special requests?

Do you offer digital copies of the photos? Are prints or albums included in the package?

How many photographers will be present on the day of the wedding? Will you be the only one shooting, or do you have a second shooter?

What is your process for scheduling and planning the day's coverage? Do you have a timeline for the day?

How do you handle downtime between events or if there are delays?

What type of equipment do you use? Do you have backup cameras and gear in case of technical issues?

How do you ensure the safety and security of the photos taken?

How long will it take to receive the edited photos? What is the turnaround time?

What is your process for editing and retouching photos? Can we request specific edits?

How will the photos be delivered (e.g., online gallery, USB drive, printed album)?

What is your payment schedule? Do you require a deposit to secure your services? What is the final payment due date?

What is your cancellation or rescheduling policy?

Do you have a written contract? What are the terms and conditions?

Do you offer any additional services, such as drone footage or highlight reels?

What packages do you offer? What is included in each package (e.g., hours of coverage, length of the final video, number of edits)?

What is your pricing structure? Are there additional fees for extra hours, travel, or special requests?

Will you provide a raw footage option, or is only edited footage available?

How many videographers will be present on the day of the wedding? Will you be the only one filming, or do you have an assistant?

What is your process for planning the day's coverage? Can we discuss a timeline and specific shots we want?
